**FROM THE P.S. I.S. 111 ByLAWS:**

SECTION 3. DUTIES OF OFFICERS

...

3.5 FUNDRAISING OFFICER OR CO-FUNDRAISING OFFICERS: THE FUNDRAISING OFFICER OR CO-FUNDRAISING OFFICERS SHALL BE RESPONSIBLE FOR WORKING ON NEW FUNDRAISING IDEAS AND STRATEGIES AND FOR IMPLEMENTING THE FUNDRAISING PLAN THAT HE/SHE, THE TREASURER AND THE EXECUTIVE BOARD PLAN FOR THE YEAR. THIS SHALL INCLUDE COORDINATION OF THE SCHEDULE OF FUNDRAISING EVENTS AND COMMUNICATION BETWEEN ALL THE PTA FUNDRAISING COMMITTEES. THE FUNDRAISING OFFICER OR CO-FUNDRAISING OFFICERS SHALL PREPARE A FUNDRAISING CALENDAR AS WELL AS FUNDRAISING UPDATES FOR ALL REGULAR EXECUTIVE BOARD MEETINGS AND GENERAL PTA MEETINGS. ALL SIGNIFICANT FUNDRAISING DECISIONS WILL BE VOTED ON BY THE EXECUTIVE BOARD.

- SCHOOL LEADERSHIP TEAM MEMBERSHIP: THE PRESIDENT OR CO-PRESIDENT OF THE PTA SHALL AUTOMATICALLY SERVE AS A CORE MEMBER OF THE SCHOOL LEADERSHIP TEAM. (IN THE EVENT THAT THE PTA ELECTS CO-PRESIDENTS, REFER TO ARTICLE IV, SECTION 3.1 OF THE PTA'S BYLAWS.) ALL OTHER PARENT MEMBER REPRESENTATIVES SHALL BE ELECTED BY THE GENERAL MEMBERSHIP.

**FROM CHANCELLOR'S REGULATION A-655:**
